# KEY RESPONSIBILITIES: JOB SPECIFIC DUTIES

- Accountable for delivering the internal auditing programme across all Group sites.
- Regular site visits to all Group sites to ensure that all Health, Safety, Environment and Quality
  procedures are being followed, prepare internal reports and action plans to advance HSEQ
  standards across the Group.
- Advising relevant site personnel on the completion of risk assessments for all relevant activities within the Company, signposting to all procedures/forms/guidance on IMS.
- Conduct regular site inspections and meetings with safety and environment representatives.
- Report findings/outcomes and remedial action on the ASSURE system.
- Advise on specialist areas, eg. fire regulations, hazardous substances, noise, heat, vibrations, machinery safeguarding, occupational diseases etc. as required.
- Assist the Site Manager as required with any enforcing authority, ie HSE, Fire and Rescue, Environment Agency, on inspections, investigations, prosecutions etc.
- Provide advice and support to all personnel to ensure compliance with relevant procedures.
- Support relevant personnel on Health and Safety investigations.
- To ensure compliance for issue of PPE, advising as appropriate for the needs of varying company roles.
- Working with the HSEQ team and the Marketing and Internal Communications Manager to ensure effective communication with all personnel by using a range of communication media e.g. health and safety display board, IMS, signage, poster campaigns, leaflets, tool box talks etc, to ensure that all stakeholders are kept up to date with health, safety, environmental and quality matters.

- Take an active part in HSEQ meetings both at site level and Group level.
- Prepare reports and KPIs as required.

- Experience At least 3 years' experience within a full time Health and Safety role with a NEBOSH certificate or similar and at least 1 years' experience of environmental responsibilities. You must be able to demonstrate continual professional development too.
